- An Abstract of 300 words with 5 keywords has to be submitted.
- Acronyms and abbreviations should be avoided unless the term or institution is introduced earlier in the text.
- The full paper should be between 5,000 and 7,500 words including Abstract, Notes, References and Author's Note.
